POLICY OBJECTIVE

To financially assist Western Australian Officials:

- a) Nominated by the Western Australian Ice Skating Association (WAISA) to the Australian Figure Skating Championships (AFSC) or the Australian Adult Figure Skating Championships (AAFSC).
- b) To gain and retain ISU standing.

In all cases the Official applying for the funding must be a current member of WAISA.

POLICY

Australian Figure Skating Championships

1. WAISA will provide funding to non-professional Officials and Trial Officials up to a maximum of \$1000 to attend the Australian Figure Skating Championships or the Australian Adult Figure Skating Championships as a Judge or Technical Official. The amount of funding will be determined by the activity of the Official in WAISA Competitions and Championships during the year preceding the Championships.

and will only be paid once during a calander year.

A per diem of \$50 per day will be paid in addition to this amount for each day of active service on the panels at the AFSC or the AAFSC.

Additional funding of \$50 per attendance at a WAISA Test Session during the year preceding the Championships will also be awarded

Officials must provide WAISA with receipts to cover the amount of funding that they are awarded.

2. Professional Officials (members of the Australian Professional Coaches Association) will be paid a per diem of \$50 per day for each day of active service on the panels at the AFSC or AAFSC when they do not have an athlete competing in an event on that day and \$25 per day where they have an athlete competing on that day. An additional \$50 will be awarded per attendance at a WAISA Competition or Championships during the year preceding the Championships.

Professional Officials and Trial Officials who travel to the AFSC or AAFSC to serve on the Panels but do not have an athlete competing in the Championships will be eligible to the same funding as a non-professional Official and Trial Officials as detailed in Part 1 of this policy.

3. If WAISA is the host state for the AFSC or the AAFSC then no WAISA funding is payable to Officials and Trial Officials. A per diem of \$15 per day will be paid for each day of active service on the panels as the AFSC or AAFSC.

4. If WAISA is the host state for the AFSC or the AAFSC then Professional Officials will be paid a per diem of \$15 per day for each day of active service on the panels at the AFSC when they do not have an athlete competing in an event that day.

International

6. WAISA will provide funding to Officials (professional and non-professional) nominated by ISA to attend ISU examinations in Frankfurt or Officials invited to attend International events to a maximum of \$1,250.00 annually. Officials must provide WAISA a copy of the nomination or invitation, together with travel receipts and details of funding received from any other source e.g. ISU or ISA.
